UPDATES:

- Safety Update:
 - Front door buzzer is in the works (ADA compliance project)
 - Quote for cameras (internet with district) outside vendor approved by LAUSD
 - Measured windows get back to us with options
 - Water update supposed to install water filling station 2 tiered system with filling stations / filtration system
 - Asphalt resurfacing / ADA / water / buzzer all related waiting for final plan needs to be approved by DSA (state architect) for asphalt work, and water is part of that upgrade.
 - Alissa Hill: We should mark/map legacy gifts plants & art we should mark that for upcoming asphalt resurfacing
- Brush clearance update:
 - Early May there was a brush clearance by LAUSD living oaks, dead oaks, coastal shrubs, 80% of monarch vegetation was removed. Lots of laws broken with the Coastal Commission by LAUSD
 - Working on mitigation plan to keep money to restore the site
 - Need to get an estimate to LAUSD so they can work to restore
 - Between LAUSD and Coastal Commission right now
 - Space was destroyed
